Background

Two approved fundraisers (the card party and raffle), which were scheduled for May 2nd, 2015, were postponed due to insufficient time to effectively promote both events.

Additionally, after much discussion, the Committee determined that the Golf Tournament will be rescheduled to the 2017 Sorority Year as the Cotillion will be held in 2016. Further, the Masquerade Theme Ball will be deferred until further planning and resolution are conducted.
